Updates and Agreements

Effective as of April 1, 2019

- 1. **Updates -** Crystal Lake Conservatory reserves the right to update, change, or otherwise adjust these policies at any time.
- 2. **Agreements -** As a registered and/or enrolled family at Crystal Lake Conservatory, you agree to the policies and procedures outlined in this document. Failure to do so will see the student and/or family dismissed without refund.
- 3. **Availability** An up-to-date copy of this Handbook will be included in each weekly newsletter, as well as available at any time on our website, www.crystallakeconservatory.com. As a registered and/or enrolled family, you understand and agree to all changes as they are presented. Please contact the office within 30 days of receipt should you wish to retract your agreement.
- 4. Eligibility All families must agree and adhere to CLC policies (outlined in this document) to be eligible for enrollment in CLC classes, events and choreography.

Contact Information

Effective as of July 1, 2018

- 1. **Returning Family Registration JASOD** families have had a Jackrabbit account created for them during this transition to Crystal Lake Conservatory. Please sign in and check the information.
- 2. **Online Registration -** New families are encouraged to register online by creating a Jackrabbit Parent Portal family profile. Classes can be chosen through the Jackrabbit app, as well as viewing payments, balances, and tax forms.
- 3. **Paper Registration -** New families who register via email, phone or brochure form agree to have a C.L.C. office administrator input the information into a Jackrabbit Parent Portal family profile.
- 4. **Required Information -** All C.L.C. families must have the following information on their Parent Portal. Information must be current and up-to-date:
 - Parent Name(s)
 - Dancer Name(s)
 - Dancer D.O.B.
 - Valid Email
 - Valid Phone Number
 - Emergency Contact
 - Health Issues and/or allergies
- 5. **Recommended Information -** C.L.C. families are encouraged to provide the following information via their Jackrabbit Parent Portal family profile:

6. **Confidentiality -** All information shared with C.L.C. via Jackrabbit or paper registration is kept strictly confidential. Recommended Information can ONLY be accessed by the main login parent, the Artistic Director, and/or the Office Manager. Required Information may be accessed by the above, in addition to Instructors and Office Administrators.

Registration and Reservation

Effective as of July 1, 2018

- 1. **Registration: Returning Families -** Returning JASOD/C.L.C. families will have priority access to registration each year. Classes may be enrolled via Jackrabbit by April 15^{th} of each year.
- 2. Registration: New Families Registration opens to new families on May 1st of each year. Classes may be enrolled via Jackrabbit.
- 3. **Registration Days** The office will be open throughout the summer to help with registration, uniform orders, questions and information. Please see posted summer hours.
- **4. Reservation:** To keep a dancers' space in a class reserved, a deposit of \$100.00 per dancer must be received within 15 days of enrollment. If deposit is unpaid by the 15 day mark, the dancer may be removed from the class list to allow for waitlist registration. Should space be available, the dancer is welcome to re-enroll at any time.
- **5. Rolling Registration:** Registration will close when either:
 - a) The class is filled. A Waitlist will begin.
 - b) Term Two has begun. Family will be contacted April 15th for Next-Season registration.

Bullying, Behaviour, Representation

Effective as of April 1, 2019

1. **Bullying -** Crystal Lake Conservatory upholds a "no tolerance" bullying policy. This extends to students, parents, guardians, and faculty. CLC is built on trust, respect, and discipline by providing a physically and emotionally safe and secure environment for dancers, assistants, staff, parents, and extended family members. To protect the rights of students, acts of bullying, harassment, and other forms of aggression and intimidation will not be tolerated. We expect no tolerance for bullying and expect behavior that promotes being respectful, civil and family oriented.

'Bullying' or 'Harassment' is any gesture or written, verbal, graphic, or physical act (including electronically transmitted acts – ie; cyber bullying through the use of internet, cell phone, pda, computer, or wireless handheld device), that is reasonably perceived as being dehumanizing, intimidating, hostile, humiliating, threatening, or otherwise likely to provoke fear of physical harm or emotional distress. Bullying and harassment is conduct that substantially interferes with the opportunities, benefits, and/or programs of one or more students and could adversely affect their participation in these programs. Bullying on the part of any Member (family, student, or staff) may lead to probation or dismissal.

- **2. Behaviour -** Should there be evidence or complaint that Members have conducted themselves in a manner that does not reflect the anti-bullying culture, CLC reserves the right to dismiss, without refund. Please observe this anti-bullying policy now posted and effective immediately. Negative and disruptive behavior will be investigated, and appropriate consequences and measures taken to address the situation.
- 3. Representation Members of CLC are viewed as representatives of Crystal Lake Conservatory. Members agree to uphold the standards of CLC, and conduct themselves in a professional, respectful manner. Dancers and their families in our Competitive and Pre-Professional Division are not permitted to take class, compete, or own/operate at another dance school, studio or program within the confines of the Grand Erie District School Board. Dancers in our Training, Performance, Conservatory, Competitive, and/or Advanced Training Divisions are not permitted to "Poach", recruit, or directly advertise of or for another dance school, studio, or program within 30 km. Students shall refrain from posting profanity, illicit materials, sexually explicit content, slander towards our school or teachers, content glorifying illegal activities, alcohol, or drug use, and discriminatory, racist, or sexist remarks.
- 4. **Reporting -** Please report instances of bullying or harassment to studio staff so that violations of this policy can be addressed appropriately.

Private and Semi-Private Lessons

Effective as of July 1, 2018

- 1. **Tuition Fees –** Current C.L.C. members are offered a rate of \$25.00/30 minutes. This rate is the same, regardless of teacher or style.
- 2. **Tuition Fees -** Non-Members pay a fee of \$30.00/30 minutes for all private lessons.
- 3. **Studio Rental -** When looking to rent space for a rehearsal WITHOUT a teacher, Members pay \$10.00/30 minutes, while Non-Members pay \$15.00/30 minutes.
- 4. **Semi-Private Lessons** In the case of two or more students (up to a maximum of 6), the full rate will be split amongst the participants.
- 5. Bookings All Private lessons MUST be booked and paid for through the Jackrabbit Parent Portal. Teacher and studio availability are discussed directly with the teacher, or with the Artistic Director. It is then the teacher/A.D.'s responsibility to input the class into Jackrabbit for Portal enrollment. Bookings NOT made through the Jackrabbit are NOT covered under C.L.C. insurance, and therefore the parent and instructor are both liable for injuries and damages.
- 6. Payments Private lesson fees must be paid in full PRIOR to the start of the class time.
- 7. **Discounts -** Private and Semi-Private lessons are NOT eligible for Volume or Payment Plan Discounts.

Medical and Media Release

The Health Information/Medical Waiver form and the Media Permission Waiver form must be filled out and included with any new student's registration. This form is provided for reference only; agreement was given with Jackrabbit Parent Portal sign-up.

I, the parent/guardian of my child/children, am aware that participation in dancing is potentially dangerous and involves risk of injury. I understand that these risks include, but are not limited to injury to ligaments, muscles, tendons, bones, and other aspects of the body that may include head, neck, or spine. Due to the dangers of this activity, I understand the importance of my child following the teacher's instructions regarding techniques, training, and other rules and agree that my child will obey these instructions. In consideration for allowing my child to participate Crystal Lake Conservatory activities, I hereby assume all the risks associated with the sport of dance, and I agree to release Crystal Lake Conservatory and its employees or agents from any and all liability/responsibility which may arise in connection with my child's participation in activities.

I authorize all medical and surgical treatment, X-ray, laboratory, anesthesia, and other medical and/or hospital procedures as may be performed or prescribed by the attending physician and/or paramedics for my child and waive my right to informed consent of treatment. This waiver applies only in the event that neither parent/guardian, nor emergency contact can be reached in the case of an emergency.

Media Release

I agree to waive all rights relative to the transmission and publication of all images recorded on any media by Crystal Lake Conservatory or its assigns, for the sole use by Crystal Lake Conservatory. I agree that these images may be used for the intended publication, promotion, marketing and any other requirements of the company. Digital photographs and video clips will be collected by the Instructors at Crystal Lake Conservatory for use in social media and the annual yearbook. All media is collected under the Youth Protection Advocates in Dance Professional Creed, outlining appropriateness, laws, and conservatism.

Pickups, Late Pickups, Sign-In/Sign-Out

Effective as of July 1, 2018

- 1. Pickups: Picking up dancers after their class should happen in our main lobby. Parents are not permitted in the dressing rooms unless accompanying a dancer under the age of 7 who requires assistance. Please alert the teachers if a different person than usual is picking up the child (grandparent, babysitter, carpool, etc).
- 2. Late Pickups: It is our policy, in accordance with YPAD, that after 15 minutes lateness, the teacher shall call all numbers listed on the Jackrabbit Parent Portal. After 30 minutes (and no answer from the numbers) the police will be called. At no time will a dancer be transported in an Instructor's personal vehicle. Teachers are not permitted to drive the child home. It is a safeguarding policy that the instructor alert the police that they are alone with a child (especially if it is after the last class of the night).

Should the lateness become a problem, an after-care fee may be charged to cover the Instructor's time to sit with the child.

3. Sign-In/Sign-Out: Large events, such as dress rehearsal, gala, recital, picture day, auditions, etc, require a parent or guardian sign the dancer in prior to the event, and sign-out at the end of the event. This is to streamline the busy backstage area for our volunteers, and to ensure each child is safe and accounted for.

Payments and Fees

Effective as of July 1, 2018

- 1. **Tuition Amounts** Crystal Lake Conservatory ("C.L.C.") prides itself on being affordable while providing the best possible arts instruction. Tuition fees take into account the cost of building rental, upkeep, equipment, instructors, insurance, and Wi-Fi access. Tuition amounts are calculated on an annual rate per minute. The 2017-2017 (JASOD) rate was \$0.28/minute/year. The 2018-2019 (C.L.C.) rate is \$0.30/minute/year. Each course is listed on the Jackrabbit with the annual tuition fee. A fee chart is attached at the end of this document.
- 2. Deposit In order to reserve a space within a course, a deposit of \$100.00 per dancer (per year) must be received within 15 days of enrollment. Failure to do so will see the spot released for open enrollment. Deposits for 2018-2019 may be done via Credit Card or E-Transfer.
- 3. **Membership Fee** A membership fee of \$20.00(+hst) per dancer, or \$45.00(+hst) per family is required annually to cover the admin required for Jackrabbit setup, and general enrollment. Members also receive discounts on events, master classes, and uniform orders. This fee is non-refundable.
- 4. Costume Deposits A deposit of \$50.00 per dancer, per course, is required to order a recital costume. Fees are due September 15th. This fee is non-refundable. Costume balances are posted on January 15th and are due before costumes will be released.
- 4. **Discounts -** C.L.C. offers two on-going discounts to help assist our families. Both are outlined below:
 - Payment Plans: Overall discounts available based on schedule of payments. Payment plans are for Full Term classes only, and are not applicable to Summer School courses.
 - Annual Payment: Save 10% when you pay in full by September 15th.
 - o Term Payment: Save 5% when you pay in two installments, September 15th & January 15th.
 - o Sessional Payment: Four quarterly payments, Sept. 15th, Nov. 15th, Jan. 15th and Mar. 15th.
 - o *Monthly Payment*: Pay for September and June upfront, and divide the remaining balance into 8 equal payments. Payments due the 1st of each month.
 - Loyalty Discounts: Discounts are offered based on the TOTAL amount of hours a family incurs in a dance season. Payment plans are for Full Term classes only, and are not applicable to Summer School courses.
 - Save 5% off the annual balance for 5 hours or more, per week.
 - Save 10% off the annual balance for 10 hours or more, per week.
 - Summer Discounts: Discounts are offered on the TOTAL number of complete camp weeks enrolled by a SINGLE STUDENT. This discount does not include Competitive Division Intensive, Grades Preparation classes, or Vocational Preparation classes.
 - SAVE 10% when a single student is enrolled in 3 or more weeks.
 - Save 15% when a single student is enrolled in ALL camps.

- 5. Late Payments Payments are due either of the 1st or 15th of the month (depending on your chosen payment plan). Payments later than 3 business days are subject to an Automatic Payment Withdrawal (see below) in addition to a 5% late fee. Two successive late payments will result in the dancer sitting out of class. NSF cheques or declined debit/credit card transactions are subject to a \$40.00 fee, to cover the same amount set by our bank.
- 6. **Required Goodwill** As a show of good faith and commitment to C.L.C., all families are *required* to have on file either a Credit Card Authorization or Post-Dated Cheques. These will not be charged/deposited except in the case of Late Payments (see #5 above) or Dropping/Withdrawal (See page 6). Forms are available at the end of this document, or online HERE.
- 7. **POS Options** C.L.C. is very excited to accept the following options for the convenience of our families:

Dropping and Withdrawal

Effective as of July 1, 2018

1. **Dropping -** "Dropping" refers to the lessening of a course load. Should the dropped course affect Competitive Team eligibility, or Examination eligibility, allowances may be reviewed.

Dropped courses offer a pro-rated refund, less discounts, less a 30-day penalty, when notice is given in writing, and Term Two has not yet begun. After January 1st, all tuition fees are non-refundable.

Costume deposits and payments are non-refundable.

Competitive fees are non-refundable.

Registration fees are non-refundable.

2. **Withdrawal -** "Withdrawal" refers to leaving ALL C.L.C. courses. In cases of withdrawal due to medical or compassionate issue, a pro-rated refund, less discounts, less a 30-day penalty, will be given when notice is provided in writing. In all other cases, refund are available only until the start of Term Two.

Costume deposits and payments are non-refundable.

Competitive fees are non-refundable.

Registration fees are non-refundable.

- 3. **Refund Policy** Applicable refunds, minus Membership Fees, Deposits, any partial-payments made, and a 20% re-staging fee, and less a 30-day penalty. Refund requests must be made IN WRITING (not online), prior to the beginning of Term 2. Refunds take 4-6 weeks to process, and a cheque is sent via Canada Post.
- 4. Credit Policy Or, a credit of the full amount can be applied, good for 12 months (at which time, there is no refund).

Uniforms and Costumes

Effective as of July 1, 2018

- 1. **YPAD** Crystal Lake Conservatory ("C.L.C.") is certified and registered with Youth Protection Advocates in Dance. All C.L.C. Instructors must adhere to the Y.P.A.D. creed, which includes both personal, and professional forthrightness and transparency. C.L.C. follows Y.P.A.D.'s expectation of age-appropriate uniforms and costumes.
- 2. **Uniform Policy** The Uniform Policy is in place throughout all four "Schools". Specific uniform requirements can be found <u>HERE</u>, or as an attachment to this document (<u>PAGE 25</u>)

As a conservatory level school of dance, our dress code is an important part of our curriculum. Showing respect for a dress code helps foster the required discipline it takes to learn a classical art form. We want out students to focus on their own individual journey as a dancer, without worrying about "fitting in" or being self-conscious of their dancewear. As such, each class level adheres to the same uniform expectations. Many dance schools require the purchase of a new leotard per level – in an effort to reduce the costs to our families, as well as being cognizant of growing bodies, each uniform colour is kept for two consecutive grade levels.

Styles and colours are chosen in accordance with examination requirements set out by the Royal Academy of Dance (R.A.D.), Acrobatic Arts (A.A.), Imperial Society of Teachers of Dancing (I.S.T.D.), and Associated Dance Arts for Professional Teachers (A.D.A.P.T.).

Uniforms must be worn to each class. In the case of special-orders or alternations, uniform compliance expected no later than the end of the second week of dance.

- 3. **Philosophy** C.L.C.'s philosophy on the use of uniform in training is shared among professional dance educators. Simplicity is one the distinguishing characteristics of a truly fine dancer. While dancers are working on the strength and technique needed to accomplish the goal we start with being simple in dress. As the dancers develop their skills, uniforms allow the Instructor, Choreographer and/or Coach to see the dancers' alignment and positioning. Baggy or distracting clothing can be dangerous to a dancer's developing body as the Instructor is unable to see and make corrections. A uniform also allows all students to be equal: no one is standing out, or trying to fit in. This is very important in the creation of the team unity in the class and puts the focus on artistry in that it allows students to express their individuality through movement, rather than fashion.
- 4. **Store** Our uniform is available through our convenient on-site store. This allows both for ease of purchase, as well as guaranteeing parents are getting the correct garment style. Parents are able to save them both time and money in not needing to drive to far-away stores, or having to travel a second time to exchange an incorrect item. Fit and colour are guaranteed at our store for C.L.C. students this is not so if you choose to travel to a different store. The leotards that were chosen were done so after much consideration of price, quality, fit, and Y.P.A.D. age appropriateness. All items in our store are cheaper than the same item for purchase elsewhere and include the cost of professional fittings or alterations/special orders.
- 5. **Profits** A portion of store proceeds goes to the Umbrella Arts and Media- Emerging Artist Award which helps offset some of the financial aid we give to deserving dancers annually. All dancers should receive a high-quality dance education regardless of financial hardship and C.L.C. is very proud to have the opportunity to offer this program.
- 6. **Costumes** Costume choices for both Competitive and Conservatory classes are chosen by the Instructor or Choreographer, in accordance with Y.P.A.D. outlines on age-appropriateness. Each costume will be sourced from

catalogues, consignment, and seamstresses. If cost is an issue, and you would like to request a consignment costume (SOLOS ONLY), please indicate this on your audition form. The Instructor or Choreographer has final say in costuming, and discussion with parents and students will not be entered into.

- 7. **Alterations** Alterations and special orders for uniform are included in the ticket price. Alterations, rhinestoning, fabric painting, and appliques on competitive costumes are the responsibility of the parent. The parent may wish to delegate these tasks to an Instructor at the rate of \$15.00/hour.
- **8.** Consignment Uniforms Shoes, skirts and leotards in good condition are encouraged to be passed down when outgrown to save both money and the environment. All articles can be turned in to the Store, and will be washed, dried, steamed, and displayed. Upon sale, the seller will receive 60% of the sale price.
- **9.** Consignment Costumes Competition and recital costume in good conditions are also encouraged to be re-used. Costumes can be tuned in to the Store, and will be washed, dried, steamed, catalogued, and displayed. Upon sale, the seller will receive 60% of the sale price.

Examinations

Effective as of July 1, 2018

- 1. Importance of Examinations Crystal Lake Conservatory believes in dance exams as a great teaching tool not only in developing dance technique but also in developing confident individuals. Exams encourage all students to work hard and achieve a goal. They also provide the dancer with an opportunity to demonstrate the work they have been learning each week in class to be evaluated by professional examiners. Dancers who are introduced to examinations from an early age are much better at handling pressure, and this ability to prepare for a challenging situation serves them extremely well in life. Passing dance examinations gives the student an individual sense of accomplishment and is a gratifying reward for the hard work that they put in all season long. It also gives them a certificate to show for all their hard work and accreditation for their dance training. Examinations create a worldwide standard and exam results can also be included on resumes. This will have a great effect of showing your commitment and seriousness to an extra-curricular subject, which is an asset when applying for schools and jobs in any area.
- 2. **Acrobatic Arts -** AA Examinations are available from Primary through to Pre-Professional Three. Exams usually fall in March just before March Break. Eligibility for an AA Levels Exam is:
 - Completion of the skills in class
 - Proficiency and consistency
 - Exam fee
 - Absence from school (if needed)
 - 1 weekend Examination Prep class (1 month prior to exam)
 - 1 weekend Mock Examination (2 weeks prior to exam)

Examination uniform is the same as worn in class. Long hair is in two French braids, into a twist; "Acro Hair". Short hair is held back with clips and hairspray.

- 3. Royal Academy of Dance RAD Examinations are available from Pre-Primary to Solo Seal. Exams usually fall in either November or May. Eligibility for an RAD Exam is:
 - Pre-Primary Grade 2 Enrolled in one ballet lesson per week.
 - Grade 3 Grade 5 Enrolled in two ballet lessons per week.
 - IF Solo Seal Enrolled in three ballet lessons per week (One being a PBT class).
 - 80% Attendance.
 - Proficiency and consistency.
 - Exam fee
 - Absence from school (if needed)
 - 1 weekend Examination Prep class (1 month prior to exam)
 - 1 weekend Mock Examination (2 weeks prior to exam)

Examination uniform for Grades Exams (Pre-Primary - Grade 8) is the same as worn in class. Classical bun.

Examination uniform for Vocational Exams (IF-AF) is black leotard. For A1-A2 is white leotard.

4. Invitations - Invitation to participate in an examination is at the sole discretion of the Artistic Director and the Instructor. Decisions will be made base on: readiness, technique, attendance, behavior, attitude, effort in class, rate of progression, proper uniform and hair, preparedness for class, and any outstanding balances. Invitations will be emailed no later than one (1) month prior to the due date.

If an invitation is not received, and you believe it to have been in error, a dancer is welcome to audition the syllabus work in a Mock Exam setting, with both the Artistic Director and Instructor present. Auditions are booked on Saturdays only, and at a rate of \$50.00. Auditions must be booked and completed no later than two (2) weeks prior to the due date.

5. Additional Preparation - In cases of struggle, an Instructor, Parent or Dancer may request additional preparation. Private lessons are booked on Saturdays only, and at a rate of \$25.00/half hour. All Additional Preparation lessons must be booked through Jackrabbit.

In cases of low attendance to the point of ineligibility, Dancers, Parents or Instructors may request Additional Preparation lessons to make up the missed hours. Private lessons are booked on Saturdays only, and at a rate of \$25.00/half hour. All Additional Preparation lessons must be booked through Jackrabbit.

Competition

Effective as of July 1, 2018

- 1. **Competitive Team** Dancers wishing to be part of the C.L.C. Competitive Division MUST attend the annual audition. Audition dates and times are listed on our web platforms, and usually take place in late August.
- 2. Summer Requirements Successful applicants are expected to participate in at least one summer program, either at C.L.C. or at another dance training institution. It is recommended that the dancer partake in the Competitive Intensive Week. Failure to do so may limit the number of dances a student is selected for.
- 3. **Choreographers -** This year's choreographers are:

- 4. **Preparations and Competitions** We will be attending four dance competitions this season from March thru April. Specific competitions and dates will be available no later than October 1, 2018. In preparation for competitions we will also be hosting a Competitive Dress Rehearsal, and a Competitive Mock Competition with a *special guest judge!*
- 5. Competitive Tuition Fees Competitive Tuition fees are per dancer, per routine. They include the following:
 - Original choreography
 - Original costume design
 - 12 weeks of 30-45 minute rehearsals
 - 2 weeks of "Outside Eye" cleaning and coaching
 - Open Studio free rehearsal days
 - 1-2 Run-Through Days
 - 1 in-studio dress rehearsal
 - 1 Mock Competition with guest judge

Competition Tuition Fees DO NOT include:

- Costume deposit
- •
- Costumes, props or accessories

- Required dancewear, shoes or tights
- Travel and accommodation
- Competition entry fees
- 6. **Absence and Makeups** Especially in the case of pieces with multiple dancers (duets, trios and groups), attendance is of the utmost importance. Should a dancer miss a scheduled rehearsal, a mandatory makeup lesson is required. There is a \$25.00 charge for each Make-Up Lesson. If your child misses more than four rehearsals throughout the year, without a legitimate reason, we will have to review their potential to continue as part of the team.
- 7. **Competition Team Requirements –** Commitment, Responsibility and Teamwork are the three pillars of a successful dance group. In order to foster these in our dancers, the following are required:
 - Successful audition.
 - Participation in at least ONE summer dance program (Intensive Week recommended)
 - Studio Wear to be worn over costume during competitions
 - 1 group number required for each solo or duet
 - No Solos for first-year competitors
 - Mandatory attendance at Comp Sundays (or required Make-Up Lesson)
 - Be enrolled, and have 80% attendance in, weekly ballet lesson(s). (1x per week for Junior School, 2x per week for Intermediate and Senior School)
 - 80% attendance at FlexTech class (Sundays) or required Make-Up Lesson
 - Respect and uphold the standards and values of sportsmanship and teamwork
- **8.** Contracts Successful Audition candidates and their parents/guardians are asked to sign and uphold a Competitive Expectations form.
- 9. **Choreography Fees** Competitive Choreography fees are outlined in an attachment to this document. Fees can be paid in full at the beginning of the dance Season (10% discount), in 2 Term Installments (5% discount), or in 4 Installments.
- 10. Entry Fees Costume deposits are due October 15th. Invoices for additional fees are distributed December 15th. They must be paid within 30 days. We realize that December is difficult for all due to holidays, to please budget accordingly.

Fees are Per Dance, Per Competition. Additional Fees are outlined below in an attachment to this document.

11. Gala - After the last competition and before recital, CLC is proud to host an annual Gala event. This will take the place of the former JASOD Solo Showcase. Top-placing competitive routines are invited to perform for guests. Each competitive family is asked to donate either:

A: A Silent Auction item

B: Volunteer for the evening

C: Sell a table of tickets

Gala event will take place in the evening and will feature a served dinner, themed decorations, silent auction, and bar. This will be our biggest Studio fundraiser each year – monies earned go toward upkeep of the building, props, Travel Trips, and bringing in Guest Choreographers and teachers.

Pointe Work

Effective as of July 1, 2018

- 1. **Background** Most girls will be asked to progress en pointe between the ages of 11-13 and of course, this is also a very important time for growth and development of bones in the feet and ankles. A thorough pre-pointe assessment is designed to reduce the risk of damage to the developing body. At CLC we ensure that each student always displays correct technique and adequate strength and flexibility to do pointe work safely.
- 2. Our Policies At times it may seem like we are being a little tough or conservative, but the reason for this is to ensure the health and longevity of the student's body. As every child has different strengths and weaknesses, started ballet at various ages, has different training and experience and has a unique body it is difficult to predict how many sessions will be needed to progress en pointe. Most students will not progress en pointe after the first session and may need anywhere between 2-6 months to complete the stages necessary.
- **3. Eligibility** Dancers wishing to be trained for pointe work MUST:
 - have passed the Grade 4 RAD Ballet Examination.
 - Be enrolled in a minimum of two Grade 5 and/or Intermediate Foundation classes per week.
 - Be enrolled in one PBT (Progressing Ballet Technique) class per week.
- 3. Process Throughout the PBT courses, dancers will learn, study and be tested on the 28 pre-pointe skills laid out by the RAD, Perfect Pointe System, and PBT. Our Pointe Work Process Policy follows that of all major ballet schools. It includes four parts:
- 1. Pass the 28 tests All tests are achievable but do require commitment and practice. How long it takes a dancer to pass the tests is very individual, and cannot be rushed.
- 2. **See the Doctors** Once the tests are completed with a grade of 3/5 or higher, the dancer is sent for an x-ray and biomechanical examination of the foot and ankle. The second step is to see a podiatrist. It is important, before progressing on to pointe, that a doctor check the placement and hardness of your growth plates. To injure a growth plate can be very detrimental to the growth of a child, and so we take every precaution to ensure a safe progression to pointe work studies. Minimum age recommended by the Royal Academy of Dance is 12. Younger than 12 or 13, the growth plates in the small joints of the feet are still quite malleable, and permanent damage to the normal use of the foot can result.
- 3. **Pre-Fit** Once medically cleared to begin pointe, the dancer will meet with their ballet teacher to choose her shoe brand. Each brand is known for supporting different types of feet. Not all stores carry all brands, so once we know which brand she needs, we can direct you to the store to book an appointment. During this meeting (15-20 minutes) we will measure the shape and size of your feet to recommend the best shoe brand(s) for you. There are many different brands of pointe shoes, each with a multitude of styles and sizes. Not all shoes will fit all feet. By having the teacher(s) assess your foot, we will be able to direct you to a store that carries that particular brand (not all stores carry all brands).
- 4. **Shoe Fitting Appointment** The fourth and final step is to attend your pointe shoe fitting. Shoes range in price, approximately \$80.00-\$120.00 per pair. For her first pair, she will also need elastics (\$5.00), ribbons (\$10.00), and padding (\$10.00-\$30.00). Subsequent pairs of shoes will not be as expensive. Elastics, ribbons and padding are reusable, and the above price for a pair of shoes includes the fitter's fee.

Fundraising

Effective as of July 1, 2018

- 1. Fundraising Types Crystal Lake Conservatory believes fundraising is an integral part to the longevity of the school and its dancers. C.L.C. offers two different types of fundraising opportunities: GFE's and IFC's.
- 2. Group Fundraising Efforts (GFE's) Group Fundraising Efforts are large-scale events which benefit the school as a whole. Events are run by the Artistic Director and Instructors, with help from Parent and Community Volunteers. Each Member family is required to volunteer for at least one event.

There are three (3) to four (4) GFE's per year:

- 1. **Crystal Gala Early June.** Cocktail affair. Families are asked to donate either a Silent Auction item, a business sponsorship, or to volunteer for the evening.
- 2. **Yearbook End of June**. Yearbooks and souvenir programs are a great way to commemorate each dancer's time at the studio. Great for grandparents, too! Sponsorship opportunities available.
- 3. Calendar December. Miss Gesila, our Resident Photographer, puts together an annual calendar featuring artistic photographs of our dancers in costume. Pre-sales begin October 15th, and calendars are available for pickup anytime in December. They make GREAT Christmas gifts for friends and families. Sponsorship opportunities available.
- 4. **Gift Wrapping Boutique December**. Held either at Simcoe Town Centre mall or at the studio. Shoppers drop off their gifts for classy and tasteful giftwrapping.
- 5. **Recital Pop-Up Shop and Concession June S**ales of snacks, drinks, and accessories at recital go towards the fees for use of the stage.
- 3. Individual Fundraising Credits (IFC's) Individual Fundraising Credits are small-scale sales or marketing opportunities that benefit the worker directly. IFC opportunities are put forth, and run by, the Parent Fundraising Committee. Past opportunities have included: Comedy Night, Chocolate Sales, and Bottle Drives. Any profits brought in are divided amongst the volunteers who worked.

Credits earned by families are held at C.L.C. and are used to pay down C.L.C. balances. A quarterly update of your individual account will be emailed. To apply a credit to a balance, please fill out the form at the end of this document, or see Miss Heather-Ami in the office.

Credits are not good for cash, and cannot be refunded, but ARE transferable. If you would like to donate your credits anonomously to another family or dancer, please see Miss Heather-Ami in the office.

4. Fundraising Committee – The C.L.C. Fundraising Committee is run by our talented Parent Volunteers. Members of the Fundraising Committee have first dibs over volunteer shifts at GFE and IFC events. For more information, or to join the committee, see our webpage HERE.




